Secretary Melanie Kenderdine, NM Energy, Minerals, and Natural Resources Division

Governor Michelle Lujan Grisham appointed Melanie A. Kenderdine as Cabinet Secretary of the New Mexico Energy, Minerals and Natural Resources Department (EMNRD) in May 2024.

Before joining EMNRD, Kenderdine was co-founder, Principal and Executive Vice President of the Energy Futures Initiative, a Washington, D.C.-based nonprofit dedicated to harnessing the power of technology and policy innovation to accelerate the clean energy transition.

Prior to co-founding the Energy Futures Initiative, Kenderdine held high-level positions at the U.S. Department of Energy in both the Obama and Clinton administrations.

In the Obama administration, Kenderdine helped create Mission Innovation, now a 26-country initiative that supports transformational clean energy research, development, and demonstration; North American grid integration and security; and the modernization of the Strategic Petroleum Reserve. Kenderdine's DOE Office led the management and analysis for the Quadrennial Energy Review, a multi-year, 22-agency roadmap for US energy policy.

During the Clinton administration, she was a primary architect of the Strategic Petroleum Reserve oil exchange of 2000, the creation of the Northeast Home Heating Oil Reserve, and the return of the Naval Oil Shale Reserve No. 2 to the Ute tribe in Utah, the largest land transfer back to Native Americans in the lower 48 in over 100 years.



Dan Najjar, Partner, Virtue & Najjar

Dan Najjar is a graduate of the University of New Mexico and the Georgetown University Law Center. He was born in Santa Fe, New Mexico and has been practicing law in the state for the past forty years, with an emphasis on administrative and regulatory law and governmental relations. Throughout his career, Mr. Najjar has represented gas and electric investor-owned utilities both in New Mexico and at the federal level, municipal utilities and for the past twenty-two years rural electric distribution cooperatives. He is married and has four children.

She has a Juris Master from FSU College of Law. James Ellison was appointed to the New Mexico Public Regulation Commission in January 2023 by Governor Michelle Lujan Grisham. The New Mexico Senate confirmed him for this position in February 2023. He is serving a two-year term which concludes on December 31, 2024.

He worked at Sandia National Laboratories for over ten years, focusing on power systems analysis and planning, including energy storage and renewable energy integration. Prior to Sandia, he worked at AES Corporation, where he managed a power plant and a distribution company.

Adrian J. Rodriguez is President of Southwestern Public Service Company (SPS). SPS is a wholly owned subsidiary of Xcel Energy Inc. that supplies retail electric utility services to over 400,000 customers in eastern New Mexico and West Texas, in addition to providing wholesale power and interstate transmission services, and is a member of the Southwest Power Pool.

Rodriguez joined Xcel Energy in 2022 from Puget Sound Energy, an electric and gas utility serving customers in western Washington, where he served as senior vice president of regulatory and strategy, overseeing clean energy strategy, regulatory and governmental affairs, new product development, and energy efficiency. He previously served as interim Chief Executive Officer and General Counsel of El Paso Electric Company (formerly NYSE: EE), an electric utility serving customers in far West Texas and southern New Mexico, and he was a member of its board of directors.

Rodriguez practiced law at Vinson & Elkins LLP in the firm's complex commercial litigation and energy regulatory practice groups and clerked for the U.S. District Court for the Western District of Texas. Prior to his legal career, Rodriguez provided policy analysis, political research and legislative research for state legislative offices, issue advocacy and political campaigns, and a Washington DC-based communications firm. Rodriguez earned a Bachelor of Arts degree with highest honors in economics and government from the University of Texas at Austin where he was a State of Texas recipient of the 1999 Truman Scholarship, a master's degree in public policy from Harvard University where he was the editor-in-chief of the Harvard Journal of Hispanic Policy, and a juris doctorate from Columbia University where he was a managing editor of the Columbia Law Review. Rodriguez is licensed to practice law in Texas and New Mexico and serves as a council member of the American Bar Association's Infrastructure & Regulated Industries Section. He is also a Texas middle and high school football official.

Chief Justice David K. Thomson

Chief Justice David K. Thomson took the oath of office on February 4, 2019, following his appointment to the New Mexico Supreme Court. He was sworn in as Chief Justice on April 17, 2024 serving a two-year term. In 2019, he founded a diversity clerkship program with the New Mexico State Bar Association and successfully launched an annual "Rule of Law Program" where schools and students in New Mexico are given the opportunity to view oral arguments in an effort to advance civics education. He was a trial court judge in the First Judicial Court before accepting appointment to the Supreme Court.

Chief Justice Thomson was born and raised in Santa Fe, New Mexico. He has an undergraduate degree in Economics and Government from Wesleyan University and received his juris doctorate from the University of Denver Sturm College of Law. Chief Justice Thomson began his career as a term law clerk for U.S. District Justice Bruce D. Black after which he joined the NM Attorney General's Office as a litigation attorney, eventually serving as Deputy Attorney General.

Chief Justice Thomson serves on the Executive Committee of the ABA Judicial Division Appellate Judges Conference and Appellate Judges Education Institute and is an AJC Delegate to the ABA House of Delegates. Justice Thomson authored the article Constitutional Long Haulers: The Undiagnosed Long-Term Impact of Judicial Review on Emergency Public Health Orders, appearing in the ABA Judge's Journal. Chief Justice Thomson is a member of the American Law Institute and is focusing on constitutional torts.

Erin Lecocq, Appellate Specialist, NMPRC

Mayane Chavez Barudin, Founder & Executive Director, Sovereign Energy

Mayane is dedicated to fostering economic prosperity and environmental justice for her community and Indigenous peoples by championing an inclusive clean energy transition. As the Founder and Executive Director of Sovereign Energy, a Native-led nonprofit, she focuses on centering Tribal energy sovereignty and amplifying Indigenous voices within the renewable energy sector. Her passion for a just energy transition was sparked during her tenure with the United Nations Secretariat of the Permanent Forum on Indigenous Issues (SPFII). Through her work with her Pueblo and Tribal Nations, Mayane recognized the transformative potential of energy sovereignty for the socioeconomic well-being of Indigenous communities. This commitment was notably demonstrated in the successful passage of New Mexico's 2021 Community Solar Act, where she spearheaded the consultation process with Tribal Nations, securing strong support from Tribal leadership and opening the solar market to Tribes.

Mayane brings a wealth of experience from both the private energy sector and various nonprofit organizations. Her professional background includes expertise in legislative campaign strategy, regulatory intervention, clean energy project development and finance, coalition building, and stakeholder engagement. She holds a Master of Science in Environmental Change and Management from the University of Oxford and a Bachelor's degree from the University of Colorado, Boulder.
