ORDER SCHEDULING PUBLIC COMMENT HEARING

THIS MATTER comes before the New Mexico Public Regulation Commission (“Commission”) upon its own motion. The Commission schedules a public comment hearing to be held on Wednesday, January 15, 2025, from 4:00 p.m. to 7:00 p.m. at the New Mexico 811 building, located at 1021 Eubank Blvd. NE, Albuquerque, New Mexico, 87112.

DISCUSSION

1. The Commission has jurisdiction over this matter pursuant to the Commission’s procedural rules.¹
2. On July 11, 2024, the Presiding Officer issued the “Procedural Order” thereby scheduling a public comment hearing to be held on November 7, 2024.
3. On November 7, 2024, the Commission issued the “Order Cancelling Public Comment Hearing,” citing the inclement weather affecting central and northern New Mexico causing unsafe travel conditions, closures of State government offices and public schools, as well as power outages that affected 50,000 Public Service Company of New Mexico (“PNM”) customers in justification for cancelling the public comment hearing. The Commission’s order did not set a new date for a public comment hearing.
4. The Commission finds it necessary and prudent, and that the public interest requires it, to schedule a public comment hearing.

IT IS THEREFORE ORDERED:

A. The Commission shall hold a public comment hearing on Wednesday, January 15, 2025, from 4:00 p.m. to 7:00 p.m., at the New Mexico 811 building, located at 1021 Eubank Blvd. NE, Albuquerque, New Mexico, 87112.

B. The Commission shall provide additional details and procedures germane to the public comment hearing in a notice filing prior to January 15, 2025.

C. PNM shall, by January 8, 2025, at its sole expense, cause notice of the January 15th public comment hearing to be published once in a newspaper of general circulation sufficient for availability in every county where PNM provides service, to be emailed to PNM's customers, to be posted on PNM's social media accounts, and to be posted on PNM's website. Publication in a newspaper of general circulation shall be no smaller than a one-half page advertisement space.

D. This Order is effective when signed.

E. Copies of this Order shall be e-mailed to all persons listed on the attached Certificate of Service if their e-mail addresses are known, and if not known, mailed to such persons via regular mail.

F. In computing time in accordance with statute, rule, or Commission order, the computation shall begin on the date that this Order is filed with the Chief Clerk or Chief Clerk's designee of the Records Management Bureau.
